Each holder of a valid membership card is entitled to greens fees and use of a golf car as if a rider fee has been paid. Should a member desire sole use of a golf car, additional fees will be required.

⁽¹⁾ Dependent Household: Includes spouse, dependent minor children living at home and unmarried children under twenty-one (21) or attending college to age twenty-three (23). Each family member playing golf is required to have his or her own membership card.

MEMBERSHIP REGULATIONS

1. All players must register in the golf shop prior to play.
2. Each member will be required to observe all U.S.G.A. rules of play except where modified by local course rules.
3. In order to operate a golf car, all drivers must sixteen (16) years of age and have a valid driver's license.
4. All food and beverage must be purchased from course. No private coolers are allowed at any time on the golf course.
5. No more than five (5) players will be allowed in any one group without prior approval of golf course manager.
6. No more than two (2) tee times will be allowed with each individual call. Tee time policy is thirty (30) days in advance.
7. Booking tee times for twelve (12) or more players may constitute a Group Outing and could require the Group Coordinator and the Golf Course Manger to sign a written Outing Agreement.
8. Membership Types as described above are not applicable to Outing or Tournament Entry Fees. A deposit will be required to hold outing or tournament tee time space.
9. Industry accepted reasonable golf attire will be required at all times. No T-shirts, sleeveless shirts or cut of shorts. Un-tattered denim jeans and pants or hemmed shorts are acceptable.
10. Metal Spikes or knobby spiked shoes, which may cause damage to the greens, are not allowed at any course.
11. No more than two (2) riders and two (2) golf bags per golf car.
12. Golf Cars must stay a minimum of thirty (30) yards from all tee and green areas. Golf Cars must remain outside the native grass areas and deep swales that line some fairways. Please observe all signs and painted white lines for golf car traffic.
13. Please allow faster players to play through at the first available opportunity.
14. Courses usually require no longer than a 4 hour and 15 minute round of play. The courses will be marshaled for speed of play and player assistance.
15. All players are encouraged to play without delay and observe all posted course information.
16. Repair all ball marks and replace all divots when playing courses.
17. Teeing off on #10 tees without the permission of management is prohibited.
